(iv) Alterations to Bank Accounts-.Cllr Collier reported that a satisfactory resolution to the complaints lodged with Nat West had not been received. It appears that the bank considers these matters resolved! A further set of forms were presented to the meeting to facilitate on line banking. Cllrs present completed.

Cllrs passed unanimously the following resolution: That the Council pursue alternative banking arrangements with Yorkshire Bank and instructed the clerk accordingly. Also resolved to reduce the necessary signatories to the account to two. The clerk presented forms for completion to open a new account.

(c) Supporting Local Communities Fund- Discussion on the subject of the Village Hall. The meeting agreed after careful consideration that the suggestion of a new hall was likely to be financially unsustainable for the foreseeable future, and agreed to consider applications to fund the renovation of the Hall to both the Supporting Local Communities Fund and the Award for All lottery fund. It was agreed that seeking external funding in this way was the most realistic approach, although success of the applications is not guaranteed. A meeting is to be held on 19<sup>th</sup> November to progress the applications, with the Village Hall Committee to be represented, and Mr M Spray to be invited to provide his professional expertise. It was further agreed to seek estimates on a number of projects for the hall, in order to assess the overall cost of the works envisaged.
